1. TERM

This Agreement shall commence on the date of signature and continue for a period of one (1) year, unless earlier terminated as provided herein.

2. INTRODUCTION OF CLIENTS

Initial Investment: A introduction fee of three percent (3%) of the value of the initial investment successfully made by the client introduced by the Introducer, paid circa 21 days of the funding of the 120-day investment. Should the investment enter a further 60 days a referral fee of 2% will be paid within 21 days of this event happening.

4. REPRESENTATION

The Introducer represents and warrants that:

- (b) They will not represent to any client or third party that they have a partnership or other formal affiliation with the Agent beyond the introducer relationship set forth in this Agreement.

This Agreement may be terminated by either party upon three (3) calendar months' written notice to the other party.
